



2008 MASLA AWARDS PROGRAM - CALL FOR NOMINATIONS - VALUED PLACES AWARD

The Minnesota Chapter of the American Society of Landscape Architects invites you to nominate a project for consideration in the 2008 MASLA Service Awards Program.

Eligibility

Those submitting nominations for a valued place must meet one of the following requirements:

- ASLA Fellow
- Past winner of the MASLA Lob Pine Award
- MASLA membership

Award Description

- I. This annual award is given to an exemplary project of landscape architecture 25 years or older that has withstood the test of time.

Selection Criteria & Recognition

1. Project is at least 25 years old but not more than 50 years old.
2. Projects completed prior to 1975 must have been designed by a Landscape Architect working in the State of Minnesota. Projects completed after 1975 must have been designed by a Landscape Architect registered in the State of Minnesota.
3. Project is largely unchanged from completion of construction to current existing condition.
4. The project's detailing, materials, and original design have endured the test of time and the site continues to be a valued place to users.

Nominations will be forwarded to the Valued Places Committee for review. The Valued Places Committee will review nominations and provide a recommendation to the MASLA Fellows. The MASLA Fellows will review all nominations and vote for one winner. The Award-winning submission will be publicly recognized and will receive an ASLA Certificate of Recognition. As space allows, the winning entry will also be featured in MASLA publications throughout the following year, including the Annual Directory and our Web site www.masla.org.

Award Winners

Award winners will be notified in early April and will be invited to the Annual Awards Banquet for recognition and appreciation. Award recipients will receive up to two complimentary tickets to the banquet. Award winners are asked to provide 4 to 5 PowerPoint slides of the project at time of construction completion and if possible of current conditions.
